KESIMPULAN DAN SARAN

5.1 Simpulan

5.1.1 Simpulan Umum

Terdapat korelasi antara *International Normalized Ratio* (INR) darah dengan konsentrasi protrombin saliva pada pasien bedah mulut dalam terapi warfarin.

5.1.2 Simpulan Khusus

Korelasi antara INR darah dengan konsentrasi protombin saliva adalah positif dan signifikan dengan hubungan yang kuat ($r = 0.81$) sehingga apabila nilai INR meningkat maka konsentrasi protrombin saliva juga akan ikut meningkat. Apabila nilai INR menurun maka konsentrasi protrombin saliva juga akan menurun.

5.2 Saran

Pemeriksaan konsentrasi protrombin saliva dapat menjadi alternatif pemeriksaan INR darah apabila pemeriksaan INR darah tidak dapat dilakukan. Pemeriksaan melalui sampel saliva juga lebih non invasif, mudah, cepat dan murah.
